

Public service philanthropy: comparisons

- Health, schools, FE, HE, cultural services, libraries, museums, youth....
- USA: \$300 billion to public service causes
 - Canada: \$10 billion to public service causes
 - UK: £10 billion to ALL charities

Public service philanthropy: comparisons

- North Americans earning over \$150k per year give 8x as much to charity as UK counterparts
- But the picture is changing...
- Earned wealth vs inherited wealth Giving back Giving trends to schools & health

Case Study: Birmingham City Council

Our recommendations:

- At least £15 million available
- £8 million from large grant-making trusts and High Net Worth Individuals in gifts of £500k+
- Over three year campaign
- A new charity must be set up and enlist HNW's, business leaders and opinion shapers as Trustees

The Proposition

- A Margin of Excellence: The Library our community deserves – not just the Library we can afford
- The public purse is not bottomless: We can expect safe and adequate but excellence requires new ways of investing/working
- The public pie is finite: money for one aspect reduces available investment resources elsewhere

Fundraising Consultancy & Project Management

What we are finding...

- The proposition is well received
- Ways in which the new Trust can enhance library services beyond fundraising are emerging
- The opportunity to engage with public service in innovative ways is driving up enthusiasm and the potential for philanthropy

Fundraising Consultancy & Project Management

What next?

- Trust will be an effective interface with education, business and cultural agencies to stimulate partnerships with library service
- Trustees will advise and assist the library service in developing new revenue streams through commercial endeavours
- Fundraising and revenue enhancement will continue beyond the completion of the immediate campaign
- Library services will always enjoy higher levels of resourcing than what can be provided by the council – at all points of the economic cycle

What can we learn?

- This is a different public/voluntary sector partnership it is not about contracting charities to deliver public services more cheaply
- Neither is it about cost reduction it's about enhancing resources – the other side of the ledger
- It is designed to broaden and augment the funding base from the outset
- Philanthropists do not expect to fill the breach if the state is seen to abdicate its public service responsibilities – but they WILL invest over and above their taxes if they can be shown the margin of excellence!
