1 Welcome Introductions and apologies

1.1 AF welcomed members to the meeting. Apologies for ab sence were received from Andy Scott (London Borough of Tower Hamlets), Denise Atkinson (London Borough of Lewisham), Jo Cleme nte (London Borough of Enfield – represented by Joyc eline Hogon), Maria Thompson (Havering College), Mick Hadgraft (TUC) and Vanita Nicholls (London Borough of Ealing).

2 Notes of the last meeting and matters arising

- 2.1 The notes of the last meeting were agreed; su bject to showing that Negat Lodhi sent apologies and was not present.
- 2.2 It was reported that London Councils had decided not to take the review of the Procurement Pledge to Leaders Committee during the pre-election period, though the Chief Executives London Committee (CELC) had reviewed and supported the proposal. This had led to some Group members noting an increase in emphasis on planning and procurement in their borough.

2.3 Dianna Neal said that there had been a follo w-up meeting with the GLA on the Apprenticeships Campaign and that an evaluation report on the London Councils/borough employer engagement programme was expected soon.

3 Update from sub-group members

3.1 An update from the London Borough of Camden was circulated.

4 The London Professional Apprenticeship

- 4.1 Sara Caplan (PwC) spoke about the London Professional Apprenticeship (Note: further details are available at this site: http://www.londonprofessionalapprenticeship.co.uk/). Sara explained the background to the initiative and that there was a target of 250 starts by the end of July 2014. The programme is suitable for apprentices employed by local authorities or their suppliers. Local charities may also benefit from hosting a project for apprentices to work as a team on solving an operationally-critical issue. Applications can be made via the Apprenticeship Vac ancies system, though Lond on Professional Apprenticeships opportunities are not flagged separately.
- 4.2 After questions and discussion, the meeting offered its support for the programme and would contact Sara directly with any queries. Sara's email address is: sara.caplan@uk.pwc.com

5 Effective working with training providers

- 5.1 Vic Fairlie provided the Group with an overview of the regulatory, quality and performance regime within which training providers worked. He suggested that local authorities should also be mindful of whether training organisations were prime contractors funded directly from the SFA or were sub-contractors.
- 5.2 Group members from Local Authorities reported varying le vels of success in engagin g with procurement / con tract management teams in their councils; and they also had different experiences in working with providers. Sharing examples of promising practice, initially among Group members, was encouraged.

If the SFA is unable to provide the information, London Councils to consider gathering the information from Local Authorities.
- 6 Apprenticeship Funding Reform (Technical Consultation)
- 6.1 Mary Vine-Morris circulated a p aper summarising the <u>technical consultation</u> on apprenticeship funding reform that was laun ched by BIS on 6 th March 2014 and confirmed it was London Councils' intention to submit a response (<u>Note</u>: the paper can be found on the <u>meeting webpage</u> along with the other papers associated with the meeting). Although responses are not due at BIS until 1st May, London Councils' submission needs political clearance before the purdah period for the local elect ions comes into force.
- 6.2 The Group expressed many concerns about the consultation, including:
- 6.2.1 The results of the earlier consultation on the p rinciples of reform did not appear to provide a mandate for the changes proposed
- 6.2.2 It was not clear if there had been a full enough assessment of the change in funding 16-17 year-old apprentices (i.e. that they would no longer be fully-funded)
- 6.2.3 The consultation did not incorporate detailed enough modelling of either of the funding systems it proposed to judge the effect on other policies.
- 6.3 Vic Fairlie provided the meeting with hard copies of the slides from a webinar on the funding reforms that was held on 7th March (<u>Note:</u> the slides have been uploaded with the papers for the meeting). Vic also drew the meeting's at tention to a repeat of the webinar being organised by FE News det ails are available at this link: http://lsect.co.uk/
- 6.4 It was agreed to support a London Councils response to the consultation that would be compiled by a combination of a special meeting of interested partners and a dialog ue via email.

London Borough of Ealing: Vanita Nicholls, Apprenticeship Programme Manager

- Labour continue to retain control and have a manifesto commitment to create 500 apprenticeships over the next four years
- The next Apprenticeship Business Dinner takes place on 2 July for employers to encourage them to take on apprentices
- The Ealing Pathways (pre-employment) Programme has been awarded an LGC Award.

London Borough of Camden: Nina Scuffil, Apprenticeships Co-ordinator:

- Camden Council will be launching an Adult Apprenticeship pilot over the summer, with the aim of creatin g 10 apprenticeships for those aged 25+, targeting single parents in particular. The Council is providing e mployers with a subsidy to enable them to pay the London Living Wage. The pilot forms part of the Council's wider agenda on maternal employment and child poverty.
- One year on from the launch of Camden's 100 in 100 campaign,100 pledges have been filled and recruitment for 4 ad ditional pledges is currently in progress. 65% of those recruited were previously unemployed, showing that the campaign has made a significant contribution to the reduction in youth unemployment/NEET levels in Camden.

Future development priorities:

- Helping to establish pathways and pre-employment training schemes into the Council scheme for vulnerable groups of young people including NEETs and Brent children leaving care
- Securing guaranteed interviews for Brent residents referred by local partners who successfully undertake and Bre nt Apprenticeship recruitment preparation programme
- Ensuring sufficient su pport for apprentices and man agers throughout the programme.

Next round of recruitment due mid-August 2014.

Launch of Brent Apprenticeships

Brent Apprenticeships launched to local SME bu sinesses on the 13th May 2014. This initiative offers a free s ervice to Brent businesses with 250 employee s or less to help them set up and recruit to Apprenticeship opportunities. We are initially looking to work with 20 Brent SMEs by December 2014 as a pilot, with a view to working with a much larger number of employers as the service develops. The focus is currently on promotion of the service to the local SME community and building on existing links with local referrals partners to maximise the opportunity for Brent residents to secure the vacancies that are created.

Pre-apprenticeship and mentoring to unemployed Brent residents aged 19 - 24

Regeneration and Growth secured funding fr om the City Bridge Trust to deliver a programme of pre-ap prenticeship training a nd mentoring to une mployed Brent residents (or those with little previous work experience) aged 19-24. The programme, delivered in partnership by BACES and a local charity called P3, offers an introduction to various sectors of work, support with literacy, numeracy and ICT skills, and one-to-one mentoring support for up to six months to support these young people with job search, interview and employment skills. The programme is due to run until Jun e 2015 supporting a maximum of 120 resident s. To date 20 residents have started the programme and 2 job outcomes have been achieved.

Maximising construction-related Apprenticeship opportunities for local residents

As part of the Council's wider initiatives to maximise local employment, apprenticeship and training opportunities from physical rege neration in the Borough and Council procurement, we are tendering to adopt a preferred partner to support in the creation and delivery of construction-related apprenticeships in Brent. The ambition is to have the preferred partner in place by the end of August 2014 and extend this model to other types of apprenticeships created via other Council procurement processes as the wider Brent Enterprise, Employment & Training Initiative (BEETI) develops.

2013 - 2014 Apprenticeship Data Collection: The picture so far

1. Overview

Collection and analysis of the 2013 – 2014 London Borough Apprenticeship Data is currently underway. To date 24 boroughs have provided a response.

2. Key findings so far

The table in appendix 1. shows a comparison between 2012 – 13 and 2013 – 14 by borough. NB: These figures include numbers generated through ATAs.

Initial analysis and comparison with previous years shows:

- An upward trend of a pprenticeship opportunities created by boroug hs with an increasing proportion being generated through supply chains and ATAs.
- The number of apprentices directly recruited by the borou ghs looks to be slightly less, however we need a full set of data before drawing this conclusion.
- Of the data reported so far, 470 opportunities (36%) were for 16 19 year olds, 700 opportunities (53%) were for 19 24 year olds, and 75 (6%) were for 25+.
- 52% of the cohort was NEET before being moved onto an apprenticeship.
- 916 (70%) are working at a Level 2 apprenticeship, 316 (24%) are working at a Level 3 and only 8 (0.6%) are working at a Level 4.
- Discussions with boroughs suggest there is a lot of wor k focussing on directly supporting businesses, not nece ssarily in t heir supply chains, t o generate apprenticeships. It may be that we need to consider a way of recognising this work, even if anecdotally.

3. Next steps

- Chase remaining boroughs for their submissions.
- Complete analysis of the data.
- Share analysis with the officers that submitted the data.
- Share the analysis with London Councils CEL C lead (Tim Shields) and write an update letter to all Chief Executives with the data.
- The data can also be used to influen ce a panel discussion for the London Borough Apprenticeship Awards.
