

Current EU funding opportunities Borough briefing April 2019

Lower level of involvement

This document is an overview of EU related opportunities available as of April 2019. It includes a brief description of the calls, and more detail can be found for each in specific document. Two funding programmes currently have relevant open calls, Interreg North West Europe and LIFE. Several other types of EU related opportunities are also open such as replication programmes, call for speakers at European conferences or learning programmes.

Higher level of involvement

Call for projects: funding opportunities relating to EU programmes (ex. Horizon 2020, URBACT, Interreg)

Call for pairing programme: funding opportunities for joint work with another authority on a precise policy issue (ex. International Urban Cooperation)

Call for replication programme: funding opportunity to join on-going EU project and apply their developed findings to your local context for a set period

Call for learning programme: opportunity to learn from an on-going programme for a set period that may include site-visits, webinars and dissemination of findings by the project

Call to engage with project: opportunity to attend a workshop organised by a project, a final conference or to become a follower city to receive findings

Opportunity to attend workshop or conference: one-off opportunity to attend or speak at an EU event

REPLICATION PROGRAMME	AVENUE Replication programme	1 October 2019	Automated and electric vehicles	AVENUE is a Horizon 2020 programme that designs and carries out full scale demonstrations of urban autonomous mini-buses. It currently operates in four cities: Geneva, Copenhagen, Lyon and Luxembourg. It is looking to expand to at least three more sites starting in May 2020, that would apply and evaluate the current platform and services. The consortium is looking for participants that have experience with running similar pilots or the legal authorisation to start running one by May 2020. The shuttles are to be integrated with the existing public transport offer, and application with a manufacturer other than theirs, Navya, are encouraged. See the project's website	100,000 EUR
REPLI	TmaaS Replication programme	30 June 2019	Digital transition	TMaaS is a Horizon 2020 programme based in Ghent and aimed at improving traffic management through the creation of a traffic management dashboard based upon local data. It is looking for cities to take up the current dashboard and apply it in their context, whilst also adding new datasets to improve efficiency.	10,000 EUR
LEARNING PROGRAMME	Interreg Europe peer review programme	28 June 2019	Policy evaluation	See the projects' website As part of its Policy Learning Platform, the Interreg Europe programme has developed a peer review programme, which allows local public bodies to receive feedback and advice from other European authorities. These outside stakeholders are invited for a two-days on-site visit for an exchange, based upon which they provide recommendations. In terms of topics, the four programme priorities are covered, with low-carbon economy (electric mobility, active travel, sustainable urban mobility plans) and environment and resource efficiency (green procurement) being of interest.
